# WDFW Fish Passage Trainings

Editor's Note: Fish Passage Barriers are being documented around the country and Washington is totally involved in this important process. A Fish Passage Barrier is anything that impedes a fishes movement up or down stream. Blocking these waterways removes all upstream water from becoming available to a variety of fish species. Identifying these locations allows those with the desire, funding, and strong backs to get into the fight and open up miles of water that will only make our fish populations thrive.

#### Hello All,

I am pleased to announce that we have a handful of training courses coming up in the next few months. These courses will cover our Inventory and Assessment protocols, as well as a single training on our Habitat Survey and Prioritization Methods (two separate courses, on two separate days) which are outlined in the 2019 Fish Passage Inventory, Assessment, and Prioritization Manual (https://wdfw.wa.gov/publications/02061).

In-person trainings will be offered in Olympia, WA at the Natural Resources Building (1111 Washington St. SE Olympia, WA 98502), with the field components done in the nearby Capitol State Forest and West Bay Park.

Each course offered is independent of each other (registration for both Course 1 and 2 is not required)- but it is highly recommended that the Course One (*Inventory and Assessment*) training has been completed prior to the Course Two (*Habitat/Prioritization*) training, as many of the topics discussed during the *Inventory and Assessment* training will be referenced during the *Habitat Survey and Prioritization* training. **The In-Person**, *Habitat Survey and Prioritization* training will be limited to no more than 20 people, as we will be walking our local training stream, and want to be conscious of our impact while out in the field.

#### **Board Meeting Minutes**

Call to order: 7:06 p.m.

**February 1, 2024 Board Meeting Minutes** (recorded by Mike Wyant)

Motion to Approve: John Richmond Second: Allan Warman Vote: Unanimous

#### **President's Report:**

Tod will complement the regional biologists' presentations in his newsletter article this month.

#### **Education Report:**

Bruce commented on the fly-tying class at Wenatchee River Institute, noting that there has been a very good turnout of club volunteers to assist, in addition to the club members who are demonstration tying at each class. All of the participants (12) are from the Leavenworth area, including two who are middle school age. One of the young participants has applied to and been accepted for the Northwest Youth Conservation and Fly Fishing academy.

Discussion was held about extending a year's free membership to the participants of the tying class. Mike made a motion to do so. Allan seconded the motion. Approval was unanimous. Tod plans to attend the last session to invite participants to join the club.

#### **Conservation Report:**

Bruce continues to acquire equipment for the conservation grants that were awarded last year.

Bruce is starting to collect applications for this year's funding.

The recipients of last year's grants will be invited to make short presentations on their projects at the club meeting in September. Bruce and Gary will coordinate. Tod suggested that the recipients take photos and/or videos as they make use of the material they were provided. Photos and video could be added to the club web site to demonstrate the club's support for conservation efforts.

#### **Treasurer's Report:**

Budget for 2024: John presented the proposed 2014 budget. He noted that it is a deficit budget but also noted that the club's overall financial position remains very strong. After some discussion about specific line items there was a motion to adopt the 2024 budget that John proposed. Bruce moved to adopt. Allan seconded the motion. Approval was unanimous.

#### **Outings Report:**

Derek provided an update on upcoming outings. A handful of members plan to attend to Quincy Lake outing. An outing to Lake Lenore is being planned for April.

#### **Membership Report:**

Allan reported that he attended the fly-fishing film festival on March 7 and handed out 20 or so applications for club membership. He commented that the films were good but the whole evening's show was heavy on advertising. He incidentally mentioned that someone he had contact with said the Plain Adventure Women group is interested in fly-fishing. He will follow up with a call to explore options.

#### **Program Chair Report:**

Gary reviewed the upcoming programs for club meetings:

March: Steve Worley to present on high water fishing on the Yakima River

April: Rich Delorenzo on fishing in the Indian Ocean

May: Mike Scherer on fishing on the Methow River and at Evergreen Reservoir.

September: Conservation grant recipients

Gary commented that programs are difficult to arrange in the months of November and December due to potential weather difficulties. Gary also commented that it is time to think about a succession plan for the program chair position as he has been doing it for many years and would like to turn it over to someone else at some point. John commented that as the ability for presenters to do so remotely is becoming more and more necessary, it is essential that the club invest the technology to assure that high quality remote presentations are possible.

Allan said he has a friend who may have a good presentation if he can do it remotely.

Old business: None

#### **New business:**

Gary reported that the Introduction to Fly-Fishing class at Wenatchee Valley College filled up in the first week of registration. It starts on April 9. Gary provided three dates when additional help from club volunteers will be needed.

- May 21 for casting
- June 1 outing to Beehive Reservoir

Bruce informed the board that this would be his last year as a board member.

**Misc.** Brief discussion was held regarding the gift that was given to outgoing president Daniel Hammond.

Bruce made a motion to give Daniel a full day guided walk and wade trip on the Methow River valued at \$500. Gary seconded the motion. The motion was approved unanimously.
