# 2024 -2025 Winter Forecast for the Upper Columbia



Last winter was an El Niño winter, where our region typically receives less snow and less overall precipitation. True to form, our snowpack last winter was 35% below normal due to receiving precipitation 10% below normal levels. Additionally, a warm winter where average temperatures were 1.9° F above normal meant that even when our region receives precipitation, that precipitation is more likely to fall as rain instead of snow. Last winter, this played out as near peak flow for the entire hydrologic year in early December due to a rain event. If the precipitation had fallen as snow instead of rain, it would have been stored as snow and released later in the hot summer when salmon need adequate flows.

Fortunately, ocean temperatures indicate a high likelihood of a La Niña winter. In general, a La Niña winter has the opposite consequences of an El Niño winter – cooler temperatures, more precipitation, and more snowpack. While this is not a guarantee and there is a chance of ocean conditions maintaining an El Niño phase or a dry La Niña winter, there is a 74% chance that winter months will experience La Niña conditions. Hopefully winter provides plenty of snow and snowmelt to fill our streams for summer salmon habitat.

Call to order: 7:02 p.m.

Board Meeting Minutes from April 4, 2024 (recorded by Mike Wyant)

Motion to Approve: John Second: Bruce

President's Report: No board meeting in June, July or August. Compliments to Gary for April's excellent program at the membership meeting.

Education Report: Bruce reported that Lisa Foster from the Trout Unlimited office in Wenatchee will present to the membership in November. Other grant recipients may present that month as well but are not yet scheduled.

Conservation Report: Cascade Unitarian Universal Fellowship collected money at one of their church services to donate to the club to support the beaver analog projects. Grant money for salmon recovery projects will be available in the near future.

Treasurer's Report: Reported by John Richmond: \$12,750 in the bank. \$8,300 in the community foundation account. No outstanding bill as of the date of the board meeting.

Outings Report: Reported by Derek Corder: The Lake Lenore outing was cold and windy. The Blue Lake outing was windy with some reported fishing success. The Big Twin outing is pending. There is an outing on the St. Joe River in July. There will be an outing at Beehive Reservoir on June 1 for the students from the fly-fishing class. There is an outing scheduled for Georgetown Lake in Montana but no details were available.

Membership Report: Allen is working on getting current members to pay their dues. Allen met with the Plain Adventure Women about providing an introduction to fly fishing at some point.

Program Chair Report: Mike Scherer from the Wenatchee Fly Company (guide service) is scheduled to present at the May membership meeting. Topics may include Methow River walk and wade fishing, carp fishing, and fishing at Evergreen Reservoir for bass and pike and possibly some information about local waters. Dan suggested that Mike Scherer be encouraged to invite his followers (the group of fly fishers who attend his tying sessions and other events) to his presentation to the club so that they can see what the club is all about. Other board members agreed.

Old business: None

New business: Discussion about lost electronic equipment, particularly cords. Tod will acquire replacements. A comment was that it is hard to understand how the equipment is being misplaced.

Dan reported on the situation with the portable toilet at Grimes Lake. The previous vendor will no longer supply a unit because the access to the site is so rough. Dan sought other vendors without success and will contact WDFW about their role in providing a unit. There is a question about whether access to the privately owned land on which Grimes Lake sits is dependent on the presence of a portable toilet.

Misc. Dan requested that invitations to Zoom board meetings be sent a few days in advance of the meetings.

Gary commented on the value of the fly-fishing course that is taught each spring at Wenatchee Valley College. He noted that he and Tom will not be able to continue to teach the class indefinitely and the club will need to look at who will step up to teach the class in the future.
